## OPEN REPORT TO THE HAMILTON BOARD COMMITTEE - FEBRUARY 2012

#### **SECTION 1: HBC REPORTING**

#### 1.0 Environmental Scan

1.1 SJVD: 2010 Annual Report of the Geriatric and Long-Term Care Review Committee In 2010, the Office of the Chief Coroner Geriatric and Long-Term Care Review Committee reviewed a total of 11 coroners' cases that were referred to them involving elderly residents of acute care and long term care homes. Upon reviewing the cases, the committee generated a total of 22 recommendations aimed at preventing future similar deaths. These recommendations focused on issues and concerns related to:

- Medical and Nursing Management
- Communication and Documentation
- Use of Drugs in the Elderly
- Admissions, Discharge and Transfer Procedures
- The Acute Care and Long Term Care Industry in Ontario, including the Ministry of Health and Long-Term Care

The recommendations focus on preventing future similar deaths by building awareness and recognition of issues affecting the geriatric and long-term care communities within Ontario. For further information the entire report is available at:

# 1.2 SJHC: Ontario government's Action Plan for Health Care (Minister Mathews speech) Community and Home Care highlights

- Under the umbrella of a new Senior Care Strategy, the Minister of Health and Long Term Care outlines proposals to provide 3 million new hours of personal support to seniors in their homes, expand doctor house calls, and better coordination of how resources are allocated
- Greater public investments in home care and community support services
- Reforming the funding model to move away from a provider centered system and to a patient centered system
- Shift resources into home care, and extended family care helping to reduce the number of unnecessary emergency room visits
- Timely proactive intervention to avoid larger expenses of acute care later, including the expansion of Telemedicine Ontario
- Health Quality Ontario (HQO) to assist in the process of bringing evidence based health care into practice
- Shifting procedures out of hospitals to non-profit community-based clinics
- Adapting to changes in technology and the shifting Ontario demographic







# 1.3 SJHC: Accreditation Canada Conference Poster Gallery

SJHC's submission was titled "Operationalizing Strategy: Quality where you need it most – at home!" The poster shares our strategic framework, key success factors and outcomes, especially those that pertain to client safety. The very successful Falls Prevention strategy was featured in the poster, which is an acknowledgment of SJHC's commitment to client safety and the excellent progress we have with falls prevention and improving client's safety at home.

# 1.5 SJHC: Consumer Choice Award Insert in The Spectator, February 18th

The February 18th issue of The Spectator included an advertising insert from Consumer Choice Award. The insert was 8 pages and included photos of the October 2011 awards gala and a double page listing of the award winners and an advertisement. As part of the continued leverage SJHC expects from being the Consumer Choice Award recipients for Best Home Health Care Services in Hamilton, SJHC participated in the insert with a half-page ad.

# 1.6 SJHC: Update from September HBC Board meeting - CCAC obtaining \$8.9 million to fund 340 nursing positions in Ontario

In a document circulated on September 6, 2011 Nurses in CCACs: Providing Care and Creating Connections across Sectors by the Ministry of Health and Long Term Care (MOHLTC), three newly funded services were to be offered by the Community Care Access Centres (CCACs) through staff nurses and nurse practitioners. These programs included:

- Mental Health and Addictions Nurses in District School Boards Program
- Rapid Response Nursing Program
- Nurse Practitioner Integrated Palliative Home Care Program

Both the Ontario Community Support Association (OCSA) and the Ontario Home Care Association (OHCA) prepared letters and met with Ministry ADMs to raise concern regarding this announcement on several principles on behalf of the Home Care service providers. The process was not consultative and the announcement is not in alignment to procurement directives within the home care sector. It represents a change in practice since the role of CCAC to date has been to provide case management, but not to serve clients directly. The 340 FTE's for these programs will most likely come from the community, further straining the human resources needed to provide community care nursing.

Recent communication from OSCA with the Minister's office indicates that CCAC will only receive direct funding to hire nurses for the Mental Health program, the other new programs will need to be managed using service provider resources. More details will be made available in the coming months regarding the development and implementation logistics of these newly funded programs.







#### 1.7 SJHC: We Care / ProHome Acquisition - Press Release Excerpt

Toronto, January 31, 2012 — We Care Health Services Inc. announced the closing of its acquisition of ProHome Health Services, a community-based private health services provider to Ontario Community Care Access Centres, long term care facilities, hospitals and to individual Clients. ProHome and its team of approximately 800 health care providers will continue to operate as an independent division of We Care, under the ProHome name and brand. The acquisition will have no impact on staffing, operations or on the respective health care services offered by ProHome and We Care.

ProHome Health Services is a contracted provider of nursing, personal support and homemaking services for Ontario clients. It also provides nursing and personal support worker staffing relief for hospitals, retirement communities, and long term care facilities.

"This is a very exciting time for both organizations and we strongly believe that the opportunities created by our combined home care experience and team of front line healthcare experts will bring added value and an enhanced portfolio of services to our respective client bases," said Mike Pohanka, President, ProHome Health Services. "We fundamentally believe that two minds are more innovative than one and, given demographic trends and the national debate around Canada's healthcare system, innovation is precisely what we need right now."

## 2.0 Mission, Vision and Values Update

#### 2.1 SJVD: Medical Director Update

The Villa has hired Dr. Hugh Boyd as our new Medical Director. He will commence his responsibilities as Medical Director beginning March 2012. Dr. Boyd has a family practice in Waterdown. A graduate of the University of Toronto medical school and family residency program, Dr. Boyd selected to pursue a career serving the elderly population. He is currently an attending physician at Alexander Place long term care home in Waterdown. He is a family physician in the Burlington Walk-in Clinic. He completed a Fellowship with Care of the Elderly at McMaster University in Hamilton.

## 2.2 SJVD: Case Mix Index (CMI) Results for 2010/11

The Villa has received the results for our CMI which is 1.0538 beginning April 1, 2012. The decrease is marginal and will have minimal impact on the budget from 1.0640.

In Ontario, both Long Term Care and complex continuing care facilities collect administrative and clinical data during a resident's period of care and report that information to the Continuing Care Reporting System (CCRS).

The Resource Utilization Group (RUG-III) grouping methodology categorizes assessments into groups that have similar clinical characteristics and levels of resource use. Based on level of acuity, the RUG-III methodology supports evidence-based system and facility level planning, quality improvement and case mix-adjusted resource allocation.

CCRS data reported for Ontario LTC facilities are grouped using the 34-group version of RUG-III. The Villa's Restorative Care program has been a great benefit to the Residents to sustain the CMI level. Currently there is one Restorative Care coach and soon to be another one, which will be of further assistance.







# 2.3 SJHC: Best Foot Forward program (BFF)

The BFF program started in July 2010 as a Hamilton Niagara Haldimand Brant Local Health Integrated Network (HNHB LIHN) - funded initiative aiming to reduce or prevent lower limb amputation by providing foot and nail care services to clients diagnosed with diabetes and chronic kidney disease at existing dialysis sites.

SJHC in October 2011 brought to the BFF committee the issue of client compliance with the clients coming to the clinics. When the clients were asked for feedback on satisfaction on the service the main indicator was the clinics held did not allow enough flexibility for them to access the service. SJHC and SJHH have worked together to revamp the program to better meet the clients' needs. On February 16<sup>th</sup> and 22<sup>nd</sup> the new format will be tested at the SJHH Charlton site. If the changes show favourable outcomes, the King Street site will also change to the new model.

# 2.4 SJHH: International Outreach Program

The Nurse Manager from the Women's and Infants' Care Program is currently preparing for a International Outreach Program Team trip in February 2012. The trip will have a strong focus on Nursing goals and objectives. Team focus is on module teaching, specifically the Association of Women's Health, Obstetric and Neonatal Nurses (AWHONN) modules. International conference is currently being planned and will be hosted in Hamilton by the Women's and Infants' Care Program Nurse Managers.

# 2.5 SJHH: United Way Campaign Results

The St. Joe's Team of staff, physicians and volunteers raised more than \$30,000 to support the 2011 United Way of Burlington and Greater Hamilton Campaign. This support will contribute to many programs and agencies that make a difference our community.

#### 1.0 SJHC

# 1.1 HNHB LHIN ALS/SH Stakeholder Working Group

SJHC's Director of CSS has been involved with this group since June 2011.

Purpose of group: This group consists of Assisted Living Services / Supportive Housing (ALS/SH) providers throughout the LHIN, representatives from the CCAC and representatives from the LHIN. The intent is that LHIN funded ALS/SH agencies will work with their community partners at local planning tables to re-align ALS/SH services to target and address the needs of 'high risk seniors' — as defined in Assisted Living Services for High Risk Seniors Policy, January 2011. The HNHB LHIN implementation of this policy will make a key exception to the eligibility criteria, which is that seniors currently waiting for placement to a LTC home will be eligible for assisted living services for high risk seniors.

*Update:* We have been advised by LHIN staff that on January 31<sup>st</sup>, 2012 the MOHLTC will be providing them with an update on the Ministry's updated Assisted Living Policy for High Risk Seniors. Members of the stakeholders group will meet with LHIN staff in February to find out details of this announcement.







#### 1.2 SJHC's Future Plan for Assisted Living

SJHC is positioning itself to apply for any funding that becomes available for Assisted Living. In particular we would focus on adding the 24/7 component to our existing Neighbourhood Model program for the most at risk seniors, which would enable us to support them at home for longer.

#### 2.0 SJHH

## 2.1 West 5<sup>th</sup> Campus Redevelopment Project

Project is on schedule. Specific January updates include pre-cast panel installation well underway on the western portion of the building and beginning stages of window installation.

## 2.2 Charlton Campus - ICU Project

The entrance to the Intensive Care Unit (ICU) will be closed from Monday February 13th at 0700 to Friday February 17 (end of day). This closure is taking place for construction work necessary for the completion of the new ICU redevelopment. Phase 1 patient move is planned for March 8 and move meetings with all stakeholders have begun. Open House for SJHH staff is planned for March 2 and ICU staff and families later that same evening to inform of the project and answer questions.

## 2.3 Accreditation Canada - new accreditation decision levels

On January 1, 2012 Accreditation Canada implemented new accreditation decision levels. Client organizations now receive one of four decisions following their on-site survey: Accredited with Exemplary Standing, Accredited with Commendation, Accredited or Not Accredited. These decisions are calculated based on the organization's compliance with the standards, high-priority criteria, Required Organizational Practices tests for compliance, and survey instrument sample size thresholds. These new accreditation decision levels are retroactive to surveys that took place in 2011; we have been informed that based on the recalculation SJHH is Accredited with Exemplary Standing.
