4. MEDICAL ADVISORY COMMITTEE PRESENTATION	 Dr. Flavio Kapczinski was thanked for his informative presentation on Mind, Brain and Big Data. The presentation illustrated how it may be possible to change the trajectory in mental illness based on state of the art imaging and evidence from accumulating data. Examples of the alteration in brain structure associated with different stages and chronicity of mental illness and a potential mechanism that may lead to this associated with psychosocial deprivation. The recent "Code Red" articles illustrated the potential relevance of this data to the citizens of our city. The importance of analysis of large linked data sets which in turn may enable individual patients to have interventions tailored to their disease stage was reviewed. It was noted that unique opportunities exist in Hamilton, St Joseph's Healthcare and McMaster to create a clinical, research and educational environment to take advantage of the advances illustrated in the presented material. The Board noted the enhanced opportunities that will present when our Dovetale project enables research to use a rigorous and well managed data warehouse. Extensive discussion ensued with respect to this evolving and emerging area of research, noting that it involves a very collaborative group including representation from both the university and hospital. Discussion ensued on how organizations in the city from all sectors can link geography and big data and it was noted that there is a HAIL (Hamilton Anchor Institute Leadership) Group which meets to discuss these issues. It was noted that the revolution of intelligence based medicine is a probability in the health care delivery of the future. It was reported that there is a new Biomedical Engineering Program at McMaster which is beginning in the Fall of 2017, and that students enrolled in this program will have opportunities to do

5.1 REPORT OF CHAIR	 Thanks were extended to all JBG members who participated in the Around The Bay Road Race on Sunday March 26th. D. Higgins and P. Tice presented the SJHH "State of the Union" presentation to the St. Joseph's Health System Board of Directors last week. March 19th was the feast of St. Joseph, the Patron Saint of the Hospital. Book marks commemorating the Feast were circulated to all JBG members. L. McNeil and C. Santoni were thanked for attending the Niagara Health System Board of Directors meeting this past week. Interviews for membership on the JBG will be held during the months of April and May. The SJVD Gala will be held on April 28th. Tickets can be obtained through R. Rocci. The SJHH Nursing Excellence Awards Dinner will be held on May 30th. Congratulations were extended to C. Santoni as he will be one of the recipients of the Hamilton Community Builders Awards, which are being presented on April 24th. This award recognizes excellence in the volunteer sector.
5.2 REPORT OF PRESIDENT AND CEO, ST. JOSEPH'S HEALTH SYSTEM	 SJHS, McMaster University and SJHF is working together with the Rabin Medical Centre of Israel to create a fellowship program for young scholars. J. Kelton is working with McMaster University and SJHH on a proposed DeGroote Centre for Medicinal Cannabis Research. An update on the Executive Compensation Framework Legislation was provided. The Council of Academic Hospitals of Ontario is working to gather together innovation brokers. T. Stewart will be the representative for SJHH on this important CAHO initiative. The JBG was informed of the sudden passing of a longstanding member of the medical staff, Dr. Wm. Bensen. Dr. Bensen, an internationally renowned rheumatologist, had been on the medical staff of SJHH for over 40 years.
5.3 REPORT OF THE DEAN, FACULTY OF HEALTH SCIENCES	 P. O'Byrne provided an update on a number of important search committees which are ongoing at the Faculty of Health Sciences.
5.4 REPORT OF PRESIDENTS	• The Working Together Keeping Each Other Safe - Preventing Violence: A Report and Resource Guide was circulated to all JBG members for review. It was noted that the document has been distributed to all staff and town halls were held at each campus. The document has also been posted on the hospital external website for public viewing. Feedback will be received from all stakeholders over the next month and further updates will be provided. It was felt that it was an excellent resource document.
5.5 REPORT OF THE CHIEF NURSING EXECUTIVE	 Pressure ulcers were highlighted in the report of the CNE. It was noted that the high prevalence of pressure ulcers across Canada is a significant health care concern. Key elements in the prevention and treatment of pressure ulcers were outlined. Discussion ensued with respect to new technologies which respond to treatment of pressure ulcers, in both the hospital and community at large.

5.6 REPORT OF THE CHIEF OF STAFF	 Updates were provided on physician recruitment and physician engagement. An update was provided on the opioid strategy. As leaders in mental health and addictions, SJHH will play a pivotal role in developing and implementing this strategy. The report of the External Review on Suicides is expected to be submitted at the beginning of April. The Canadian Psychiatric Association has approved an academic section of Emergency Psychiatry. SJHH is a leader in this area and is committed to excellence in Psychiatric Emergency Services. The Search Committee for a Chief of Psychiatry is currently underway. Results of the physician engagement survey are currently being rolled out. T. Stewart will send a link to the publication "Chest Magazine" which this month is highlighting the achievements of Dr. P. O'Byrne.
5.7 REPORT OF THE PRESIDENT PROFESSIONAL STAFF ASSOCIATION	 It was noted that the March 28th Quarterly Medical Staff Meeting was extremely well attended. Dr. C. Hayes, Chief Medical Information Officers, gave a presentation on the Dovetale Project.

1. Environmental Scan

SJVD: CCAC and HNHB LHIN Update

Dr. Eric Hoskins, Minister of Health and Long-Term Care has made a transfer order under subsection 34.2(1) of the Local Health System Integration Act, 2006 (LHSIA) that would transfer all assets, liabilities, rights, obligations and employees of the HNHB CCAC to the HNHB LHIN. *See enclosed*

SJHH: Can exposure to antibiotics I the womb cause long term behavioural issues? Can probiotics diminish these effects?

In a landmark study led by Dr. John Bienenstock published in Nature Communications, researchers at St. Joseph's Healthcare Hamilton and McMaster University have discovered that in laboratory mice, exposure to antibiotics in the womb may cause long term behavioural issues, which can be diminished through probiotics.

This is only the beginning when it comes to understanding how these findings impact humans, but it brings up many questions about antibiotic use in pregnant mothers and infants. It also places the spotlight again on the benefits of eating probiotics and the infinite connections between our gut and our brain.

The expectation is that seniors who are less isolated will experience fewer hospital readmissions and emergency room visits. M. Amodeo is St. Joseph Home Care's Hospital Care Connector with the HSIIP.

SJVD: Hospice Update

Villa Hospice Project

Stakeholder engagement continues and partnerships explored with CCAC, LHIN, Catholic Council, Hospice Palliative Care of Ontario, Stedman Hospice, Juravinski Cancer Clinic, SJHH, McMaster University, Good Shepherd.

As per the previous meeting, pediatric population group continues to be explored and reviewed with the Villa Team, Regional Hospice Palliative Care Council and McMaster. There has been a noted gap in service for the pediatric palliative sector and there has been discussion regarding capacity planning in areas of Hamilton West to Niagara area. *See enclosed*

SJVD: Hospice Palliative Care of Ontario (HPCO) Convention- Accessing Compassionate Hospice Palliative Care Across the Continuum

Leads from the Villa Team will be attending this year's HPCO convention (April 23-25, 2017). This opportunity will allow the Villa Team to network with industry leaders and gain more insight with re: Hospice Palliative care and issues impacting this sector. During this convention distinguished industry experts and trailblazers will share innovative, forward-looking, evidence-based research and hospice palliative care advances.

In order to build capacity, A. Simpson and M. Wood will be taking the GPA Coaches Training in May 2017. This will bring the number of coaches to three in our agency.

SJVD: Long-Term Care Home Provincial and LHIN Dashboards

In the past five years, the long-term care sector has undergone profound change. Before then, long-term care homes accommodated a mix of residents with low to very high care needs. Since 2010 however, only people with high or very high care needs are eligible for long-term care in Ontario. These changes are largely due to the province's aging-in-place strategy, which has made more funding available for care at home while implementing new, stricter admission criteria for those entering long-term care. The result: Ontario seniors are entering long-term care homes when they are older, frailer, and in need of more medical and personal care than ever before.

Ontario's long-term care homes (December 2015)

- •627 homes are homes licensed and approved to operate in Ontario
- •57% of homes are privately owned, 24% are non-profit/charitable, 17% are municipal
- More than 40% of long-term care homes are small, with 96 or fewer beds

• Approximately 300 of the provinces long-term care homes are older and need to be redeveloped (more than 30,000 beds)

- •The average time to placement in long-term care, as of December 2015, is 103 days
- •The wait list for long-stay beds, as of December 2015, is 26,495

The Ontario Long Term Care Association has developed a series of dashboards with data related to resident demographics, quality indicators, waitlist, wait times and more, within each Local Health Integration Network (LHIN). An overall dashboard for all of Ontario, using province-wide data has been developed. *See enclosed*

SJVD: Eldercare Update

SJVD/SJHH: Senior Friendly Hospital Emergency Room Departments Initiative Update

The Eldercare Task Group re: The Senior Friendly Hospital Emergency Rooms Initiative conducted it's first review on March 24, 2017. Various aspects of the ER department were audited including: Process of Care, Environment, Leadership support, Quality Data, Psychosocial support. Information and Data have been collected and summarized and will be presented to the task group for review. ER departments in Welland Hospital and St. Mary's Hospital will be reviewed in the very near future. Special thanks to the SJHH ER Team & administration for their hospitality and assistance over the course of the review. Highlights and recommendation will be forthcoming at a later date.

SJVD: Senior Housing Initiative- RFI

In collaboration with Eldercare Finance lead, SJV will be issuing a RFEI re: the construction of a Senior housing complex that will be situated on the remaining 1 acre of land on the Villa campus. This draft RFEI will be presented to the Resource committee for review and approval. Please note: A literature review was completed and various models of care have been explored by the Eldercare Team including: dementia village, independent living, assisted-living, memory care models. Please note each Eldercare site will be issuing separate RFI's in order to expedite the process.







SJVD: Registered Nurse Association of Ontario- Best Practice Spotlight Organization Update (BPSO) In light of the number of organizational changes and leaves within each respective Eldercare site, the BPSO initiative has been put on hold. After some discussion among the Eldercare Team, plans will be made to re-apply in 2019. In the interim the Eldercare sites are currently working collaboratively on a number of best practice processes to address: 1) continence, 2) infection control 3) Pain 4) Palliative care 5) Skin and Wound
